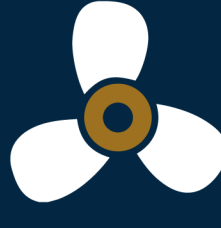
Seamless Logistics:
Shorten lead time by 75% for transporting goods to clients in North America compared to Asia.



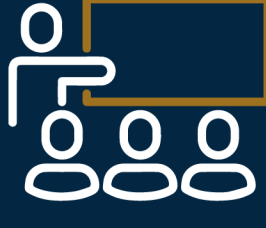
Increased Agility:

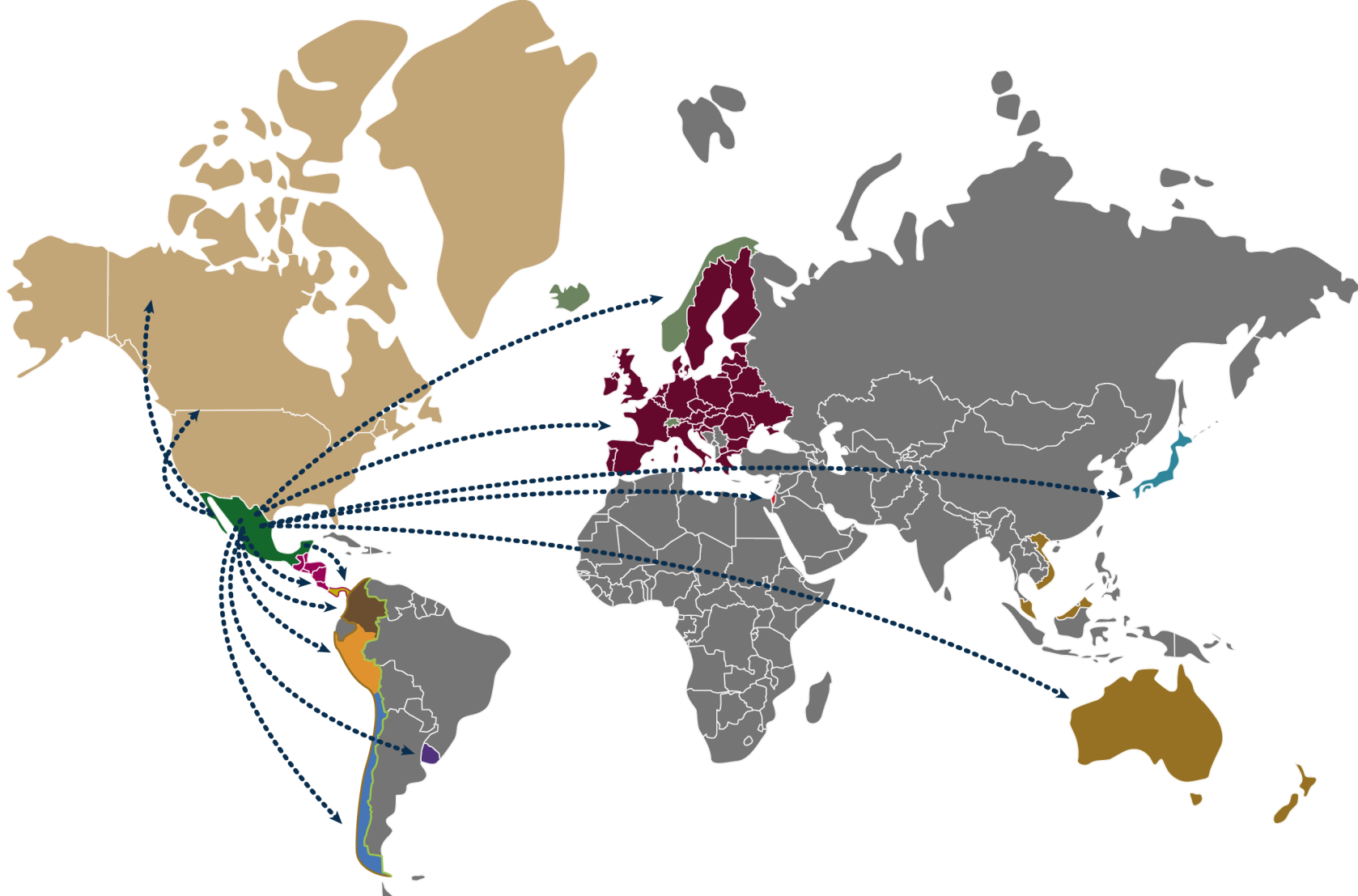

IMMEX PROGRAM

International companies can take advantage of the IMMEX program's benefits through the shelter model to optimize savings.

The IMMEX program provides companies manufacturing in Mexico with significant tax and duties advantages.

This program, combined with VAT certification, allows foreign manufacturers to temporarily import raw materials and delay or avoid payment of VAT with the stipulation that finished goods be mainly exported (directly or indirectly) out of Mexico within a government mandated timeframe.
